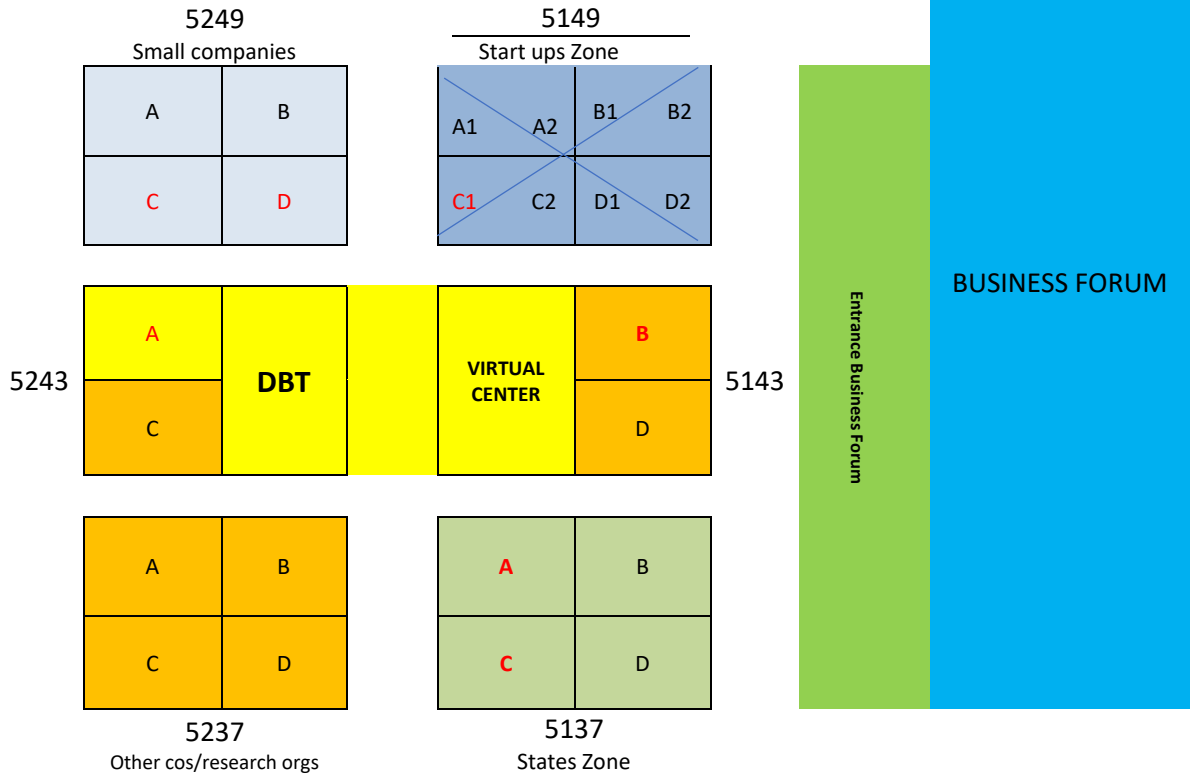

TERMS and CONDITIONS March 13, 2017

1. Investment at INR 9.5 lakhs per 100 sq. feet.
2. The 9.5 lakhs is exclusive of service tax. As per current rules Service tax is not applicable since they are delivered outside the Taxable territory of India.
3. DBT has kindly agreed to provide support the following categories of exhibitors:
 - Start ups defined as registered companies less than 5 years and less than 25 crores turnover in any of the 5 years.
 - Small companies: Less than 50 crores turnover.
 - Other companies and Research organizationsThe level of support is:
 - 100% for 50 sq ft. for Start-ups. Two startups will share a 100 sq ft booth.
 - 50% for 100 sq. ft. for small companies. Therefore, booth cost to company will be 4.75 Lakhs per 100 sq.ft.
 - 2 lakhs for 100 sq ft. other companies/research organizations. The booth cost to company will be 7.5 lakhs per 100 sq ft. In case a company books 200 sq feet the level of support will be a maximum of 3 lakhs.
4. In case of excess demand for booths available preference will be given to companies/organizations that have significant products/services reflective of the Innovative depth and creativity of Indian public and private Biotech sector. Start ups and small companies will have to send a one pager on their company's achievements and their plans for showcasing them at BIO 2017. A letter from the auditor certifying that the start-ups meet the 2 criteria (Less than 5 years and less than 25 crores annual revenues in each of the 5 years since registration) will have to be attached along with a copy of their Registration certificate. The decision taken by ABLE's committee will be final. The shortlisted companies will be informed once the cut-off date is over.
5. Selected start-ups will have to deposit a security of INR 50,000 by cheque after ABLE confirms acceptance. The Security will be forfeited in case a start-ups fails to submit its poster files by the deadline or fails to send a team member to BIO San Diego after confirming their participation. In other cases the Security cheque will be returned to the start ups within July 2017
6. 100% as advance on booking. Confirmation only on receipt of entire amount by ABLE.
7. No refund for any reason including denial or delays in obtaining of US Visa.
8. First pay - First choose principle to apply for State and larger companies.
9. Fully furnished stalls with electricals and carpeting.
10. The Exhibitor to provide finalized RTP poster files by April 1, 2017 for booth panels as per format and specifications. Any cost escalation due to delays in providing information will be borne by the Exhibitor. 100 sq feet booth will have 2 walls to display posters. 50 sq feet exhibitors will display on wall each. Poster sizes will be specified and will not be altered.
11. 100 sq feet Exhibitor provided a total of 4 EBP (Exhibitor Booth Personnel) passes allowing access to Exhibition. One of the 4 EBP passes to be utilized for the Partnering account.
12. 50 sq feet booths will receive 2 EBP passes and will share a 100 sq feet booth. One of the 2 EBP passes to be utilized for the Partnering account.
13. ONE InBooth partnering Account allowing exhibitor to invite and accept meeting requests. In Booth partnering to be provided at 10 identified spots. The schedule and location of meetings to be decided by the BIO Partnering system for which the requests have to be made by the Exhibitor well in time. Responsibility of ABLE ends with providing the Partnering Account.
14. Online Exhibitor listing provided the Exhibitor registers well in time. Late registration can lead to delays.
15. Invitation to India related sessions.
16. Access to Virtual Center and various sessions at the INDIA pavilion for networking.
17. Profile included in the Exhibitor Brochure provided all information requested is supplied in time.
18. Trip to Local industries/companies. There may be a small (25 to 30 USD per person) lunch charge extra.
19. Interaction with other Country delegations as per finalized program and availability.
20. Access to various events in the Exhibition area normally provided by BIO to Exhibitor Booth Personnel as per information in the PDF on the BIO website.
