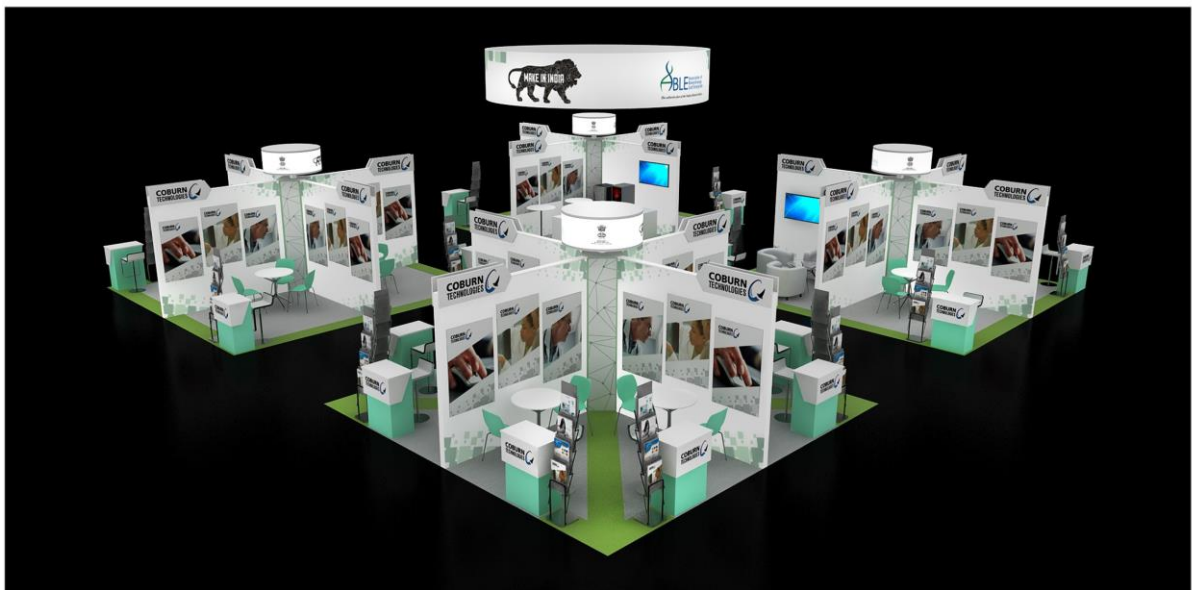

STARTUP TERMS and CONDITIONS, March 5, 2018

1. A startup is a company that has been registered for less than 7 years or has a turnover of less than 25 crores per annum – whichever is earlier. A scan of the ROC and the audited Financial Statement (2016-17) should be submitted along with the two-pager mentioned in point 3 below.
2. Eight Start-ups will be shortlisted among the applicants.
3. Selection will be based on various parameters including the Innovativeness of service or product, market readiness and Objectives of participation etc. All things being equal, first timers will be given preference. A crisp two pager describing the Company, Innovativeness of Product/Service, market readiness and objectives of participation should be mailed to anil@ableindia.org.in Only the first 2 pages will be read. Last date of receiving the applications is March 15, 2018. **Canvassing in any form will invite disqualification.** The decision of ABLE management will be final.
4. 50 sq. feet will be provided. The stalls will be allocated after the shortlisting is done.
5. Shortlisted applicants will be required to pay a Deposit of 50,000 by Cheque in name of ABLE within one week of intimation by ABLE. The deposit will not be refunded in case the start-up does not comply with timelines or is unable to come to the BIO for any reason including denial or delay in obtaining US Visa. The startup will be obliged to fill up a questionnaire provided by ABLE within 14 days of the event. The deposit will be refunded within 60 days of completion of the event. Any charge created on ABLE will be deducted.
6. In case of No Show or delays in providing final Poster/logo Files in the required format as per communicated deadlines, ABLE will have a right to cancel and reallocate confirmed booth (without refund) in order to prevent potential adverse impact on ABLE, India Pavilion and other exhibitors.
7. Fully furnished stalls with electricals and carpeting with standard furniture is provided.
8. For LCD in the booth the same will be provided on direct payment of 51,180 INR (inclusive of 18% GST) to the INDIA pavilion designer. Exhibitors can contact ABLE for details.

9. 50 sq feet Exhibitor will be provided a total of 2 EBP (Exhibitor Booth Personnel) passes allowing access to Exhibition. One of the 2 EBP passes to be utilized for the Partnering account. An amount of 4000 INR will be charged for a Booth Partnering account that will be deducted from the 50,000 INR deposit. The InBooth partnering Account allows exhibitors to invite and accept meeting requests. In Booth partnering points will be provided at 10 identified spots within the India Pavilion that may not be in the exhibitors own stall. The schedule and location of meetings to be decided by the BIO Partnering system for which the requests have to be made by the Exhibitor well in time. Responsibility of ABLE ends with providing the Partnering Account.
